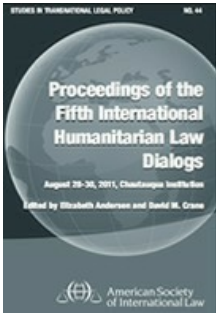

The volume also contains the prosecutors’ updates regarding the activities of their respective courts and tribunals during the past year.
