

About This Title

Cultural property is a broad concept that includes movable and immovable objects of cultural significance, whether natural or manmade, such as paintings, prehistoric tools, monuments, buildings, or geological formations. It also includes intangible cultural expressions, such as oral histories, rituals, and music. These items and expressions, throughout history, have been removed from their original cultural context due to various causes, such as war, exploitation, and more.

Within *Cultural Property: A Legal Research Guide*, researchers will find **more than 10 years of updates** in a brand-new edition that contains a **wealth of primary and secondary resources**, **such as books**, **periodicals**, **articles**, **web resources**, **conferences**, **and more**, utilizing a timeline approach to show the development of this area of law. This guide emphasizes the **importance of protecting and preserving cultural property in its original context**—both for the groups that identify with the artifacts, and for all humankind.

As a note, the concept of a global patrimony has led many to abandon the use of the phrase cultural property in favor of the broader, less economically focused notion of cultural heritage. Consistent with the first edition of this work, this guide uses the phrase cultural property unless discussing a source that specifically uses the term cultural heritage.
