

Dr. Fishman is a specialist in Pennsylvania legal history and bibliography. He has written more than 400 publications, including books, articles, chapters in books, and book reviews. His more recent notable works include co-author of *Pennsylvania Legal Research Handbook*, *Bisel's Special Education Lawsource: Federal and State Laws and Regulations*, *Pennsylvania Judicial Discipline Handbook*,

co-editor of *Pennsylvania Constitution: A Treatise on Rights and Liberties* (first ed.), and Hein legal research guides on *Judicial Ethics and Discipline*, *Grand Juries*, *Grandparents Visitation Rights*, *Pennsylvania Administrative Law*, *U.S. Post Office*, and *DNA*. He also publishes annual indexes for the *Journal of Supreme Court History*, *Pennsylvania Bar Association Quarterly*, and *Pennsylvania Family Lawyer*. Two recent web projects are the Biographical Dictionary of the Justices of the Supreme Court of Pennsylvania for the Pennsylvania Supreme Court and the Law Academy of Philadelphia for HeinOnline. He is co-Director of the Pennsylvania Constitution Website at Duquesne University School of Law. He also teaches an online Introduction to Legal Research course at the University of Pittsburgh Dietrich School of Arts & Sciences/College of General Studies and an American Legal History course in the Forensic Science and Law Program and Advanced Legal Research in the Paralegal Program at Duquesne University.
