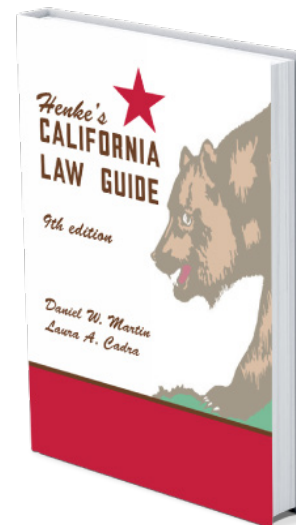

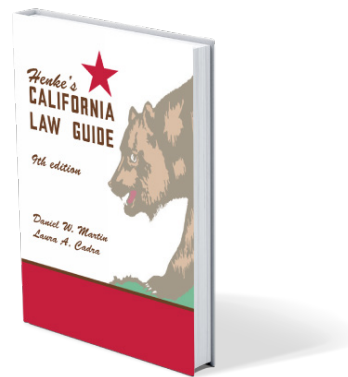
About the Editors
