### ARBITRATION and DISPUTE RESOLUTION

Arbitration is one of a series of alternatives to litigation which enables parties to solve legal disputes without recourse to a suit in a court of law. A broader term, alternative dispute resolution, does not normally include arbitration, but rather refers to such processes as conciliation, and mediation, and expert evaluation all of which are dealt with in the Civil Procedure Rules.

The basis of arbitration is statutory, specifically the Arbitration Act 1996, and numerous civil procedure rules and practice directives. In the area of international trade disputes the international convention, UNCITRAL (United Nations Commissions on International Trade Law) is foundational.
