This guide is the improvement to the seminar book and includes historical information as well as guides to CD-ROM, on-line services, and the Internet.

This work also includes a chapter by the late Tom Spaith, who served as Associate Director of the Ohio State University Law Library until his death in 1995. Tom was a frequent speaker on Ohio legal research at seminars for law students and new practitioners, and after his death, the authors discovered an unfinished manuscript regarding Ohio legal research that he had written in the late 1970's.
