

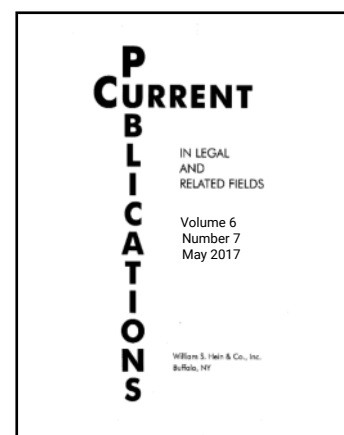
CURRENT PUBLICATIONS IN LEGAL AND RELATED FIELDS

The current cumulation of Volume 64 (2016) of *Current Publications in Legal and Related Fields* follows the general pattern established by the preceding volumes.

Subscribers are reminded that this publication, like previous cumulations, is intended to be a current awareness list for acquisition departments and not a cataloging tool, as most entries are prepared without physical examination of the items. Inaccuracies discovered in the monthly issues have been corrected in the cumulation.

Following the guidelines established by previous volumes, this publication lists English-language titles published throughout the world.

RECOMMENDED PUBLICATIONS FOR LEGAL RESEARCH

Recommended Publications for Legal Research has served as a valued resource for law librarians for more than 35 years. This basic collection development tool has a rich history dating back to 1928, when Helen S. Moylan compiled a "List of Recommended Treatises." Moylan's was the first published guide for law libraries to use in the acquisition of treatises. It was revised in 1938 and supplemented in 1942 and 1949 by Bernita J. Davis. From 1967 to 1976, Law Books Recommended for Libraries was published under the direction of Miles Price and Harry Bitner. This set of loose-leaf binders covered material published from 1967 to about 1970. Then beginning in 1979, Oscar J. Miller and Mortimer D. Schwartz designed and compiled Recommended Publications for Legal Research, covering material published from 1970 to 2000. In 2001, following in the footsteps of my law library colleagues, Mary Miller took on stewardship of this publication.

Collection development, a fundamental responsibility of librarianship, is a complicated and fluid process. As we know all too well, the sheer volume of materials published today has increased disproportionately to most of our acquisitions budgets. Additionally, the format choices from which to make selection decisions have exploded, and the traditional printed page is no longer necessarily the preferred format.

Over the past decade there has been a decisive shift in the quantity and type of material purchased by academic law librarians. Budget constraints have had a significant influence on collections. Few institutions have been spared the difficult task of having to make hard decisions about what should be acquired and what material can be skipped or dropped. For example, some librarians now acquire monographs only if requested or based on interlibrary loan statistics.

Law school curriculum has shifted also, with more emphasis on practical courses that groom students for legal practice. Therefore, the academic law library is veering toward providing more practice-oriented materials to better prepare the newest members of the bar for their legal careers which, more often than not, will be with a law firm.

The format of this volume remains the same as in previous years, with recommended titles chosen from material announced in 2016, listed by main entry under 44 subject categories, along with a subject index and a main entry index. However, the selection criteria used for this 2016 volume of *Recommended Publications for Legal Research* has shifted somewhat, to reflect current collection development reality and practices. The entries tagged as As and Bs represent materials needed for minimum to intermediate law library collections, many of which are geared toward preparing the law student for future work experience, while the Cs indicate titles that are more scholarly in nature.
