The Act also increases border protection on both the northern and southwestern borders of the U.S. and implements the recommendations of the 9/11 Commission.

In its report to the nation, the 9/11 Commission made bold proposals to protect the nation in this new era of terrorism. It called for a global strategy to attack terrorists and terrorist organizations, reach out to prevent the growth of Islamist terrorism and safeguard America from additional terrorist attacks. To achieve these goals, the Commission called for wholesale government reorganization, through "unity of effort" in five areas. The provisions of Public Law 108-458 promote inter-agency sharing of intelligence by the FBI and other jurisdictions, further strengthening homeland security. THE IMMIGRATION AND NATURALIZATION SERVICE'S CONTACTS WITH TWO SEPTEMBER 11 TERRORISTS:

A Review of INS Admissions of Mohamed Atta and Marwan Alshehhi, its processing of their Change of Status applications and its efforts to track foreign students in the U.S.

Atta and Alshehhi gained international notoriety when they hijacked, piloted, and crashed two planes into the North and South Towers (respectively) of New York City's World Trade Center on September 11, 2001, resulting in the deaths of thousands of people and the complete destruction of the World Trade Center.

Six months later, a small flight training school in Florida received official documents from the Immigration and Naturalization Service (INS) that had been processed prior to the events of September 11, 2001, approving requests that Atta and Alshehhi had made in September 2000 to change their nonimmigrant status from "visitor" to that of "vocational student." Already under heavy criticism, the INS became the target of even greater public vilification, leading U.S. President George W. Bush to direct the Attorney General to investigate the failure of the INS to handle the situation properly.
