The purpose of Willoughby's work, as stated in the preface to the first edition, was to provide a statement of the rights of foreigners and the interests of foreign states in China, as they are to be found stated in treaties with or relating to China and other official documents.

Willoughby, a lawyer and political science professor at Johns Hopkins University, served as a legal and constitutional advisor to the Chinese Republic from 1916-1917, and continued to advise the Chinese through the Washington Arms Conference in 1921 and the two Opium Conferences in Geneva in 1924-1925. In 1931, he also served as an advisor to the Chinese delegation to the League of Nations. His numerous writings on China and Japan and their relationships prior to World War II are classics that are still used in education to this day.

Reprint of Volume XVII in Probsthain's Oriental Series, with a Chinese index and an index of names and references. The Book of Lord Shang was probably compiled sometime between 359 and 338 BCE. Along with the Han Fei-Tzu, it is one of the two principal sources of Legalism, a school of Chinese political thought. Legalism asserts that human behavior must be controlled through written law rather than through ritual, custom or ethics because people are innately selfish and ignorant. The law is not effective when it is based on goodness or virtue; it is effective when it compels obedience. This is essential to preserve the stability of the State. Roscoe Pound recommended this book for the study of old Chinese law in *Outlines of Lectures on Jurisprudence* (5th ed.) 235.

Published at the beginning of China's modern era, which followed the creation of the Chinese Republic in 1911 and the abdication of the last emperor in 1912, Yen reviews significant turning points in the long history of the nation's constitutional history. This is complemented by a parallel history of public law. A student of Charles A. Beard, Yen shares his mentor's sensitivity to the decisive influence of socio-political factors. The final chapter, "Movement For a Written Constitution (1905-1910)" is especially interesting as a sophisticated contemporary account by Chinese legal historian.
