This 3-volume set is the **7th installment** of the series *A Documentary History of the Legal Aspects of Abortion in the United States*, and is devoted to the Supreme Court's decision in the case of the *City of Akron v. Akron Center for Reproductive Health*. In this decision, the Court found that the city's abortion ordinances, including required parental consent for minors, informed consent for adults, and a 24-hour waiting period, to be unconstitutional. The Courts believed these provisions “unjustifiably placed a significant obstacle in the path of a woman seeking an abortion,” and also constituted an attempt to persuade against an abortion.

More than 35 years have passed since the Supreme Court first held, in *Roe v. Wade*, that women have a constitutional right to abortion. Yet the question is still a topic of heated debate, and there has been an ongoing call to revisit past abortion decisions.

This compilation by Kumar Percy Jayasuriya and the Tarlton Law Library is **intended as a learning tool as well as a historical record**. It contains all briefs submitted to the Supreme Court, the transcripts of the Supreme Court oral argument, the lower court opinions and the final decision of the Court. It provides researchers and students alike with documents and information concerning this highly influential case in the controversial topic of abortion rights.

A record 78 *amicus* briefs were filed in this important case. These briefs argued on both sides of the *Webster* decision. The Court ultimately upheld the tough Missouri abortion statute, but did not overturn *Roe v. Wade*. The Court also upheld the constitutionality of Missouri's ban on using public facilities and public employees to perform abortions.
