The diplomatic history of Europe from 1870-1914 falls naturally into four rather sharply defined periods:

- 1) 1870—1878. From the outbreak of the Franco-Prussian War to the Congress of Berlin.
- 2) 1878—1890. From the Congress of Berlin to the retirement of Bismarck.
- 3) 1890—1904. From the retirement of Bismarck to the opening of the Russo-Japanese War.
- 4) 1904—1914. From the opening of the Russo-Japanese War to the beginning to the World War.

The book also contains two appendices: Documents; Collection of Treaties and Diplomatic Documents Most Frequently Cited.
