


Madison was an American politician and one of the Founding Fathers of the United States. Considered to be the "Father of the Constitution", he was the principal author of the document. In 1788, he wrote more than a third of the Federalist Papers, still the most influential commentary on the Constitution. Madison is also known as the "Father of the Bill of Rights", as he was responsible for the first ten amendments to the Constitution and drafted many basic laws.

Sydney Howard Gay was an author and a journalist. Gay was an active abolitionist before and during the Civil War. He edited the Anti-Slavery Standard and Chicago Tribune and served on the editorial board of the Saturday Evening Post.
