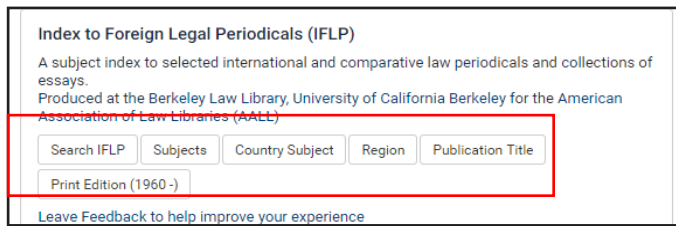

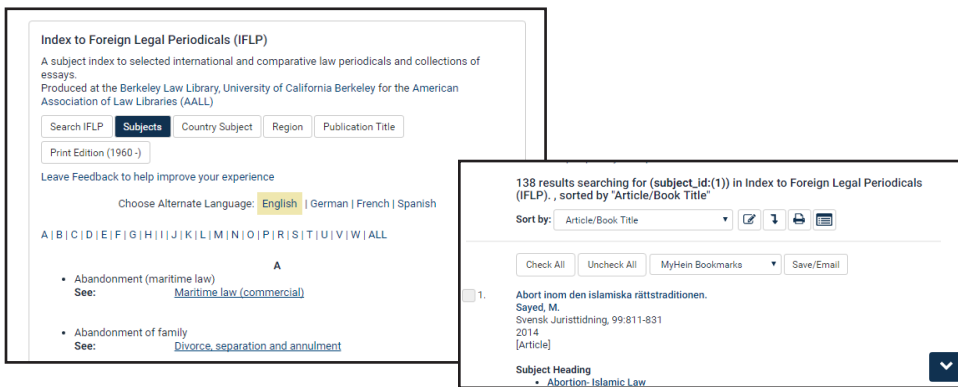

Translating a Japanese Labor Law Treatise

INTRODUCTION

I recently translated from Japanese to English a treatise on Japanese labor law written by Professor Kazuo Sugeno of the University of Tokyo Law Faculty. In Japanese, the treatise runs to approximately 650 pages, including end matter (i.e., prefaces, table of contents, indexes). It will print to about 750 pages in English when it is published at the end of 1991 by the University of Washington Press.

By describing how this project was achieved and what was learned from it, this article seeks to persuade other law professors, law students and lawyers — especially those who have not had prior
