The court exercises jurisdiction over civil, family, probate, criminal, juvenile, gaming, wildlife and animal control cases. The court takes appeals, which are heard at the Southwest Intertribal Court of Appeals (SWITCA) (P.O. Box 4456, Station A, Albuquerque, New Mexico 87196). The appellate court administrator assigns appeals court judges on a case-by-case basis. Judges attend continuing education and chief judges and associate judges are law-trained. Requirements for admission to the court: licensed attorneys or lay advocates in good standing and a \$10.00 admission fee. Court opinions are not published. The tribe's codes are published and available for a fee from the office of the chairman of the tribe.
