- The U.S. government claimed that Iraq had weapons of mass destruction, was planning to attack the United States, and was actively supporting the terrorists who had engineered the 9-11 attacks; these charges eventually were proven to be false.
- The Iraq War has been very costly: more than 4,343 lives lost, 13,861 seriously wounded, and more than \$400 billion.



These controversial topics are discussed in this set and are accompanied by a compilation of material on American public law and policy including documents from the federal legislative branch such as congressional bills, debates, reports, and hearings; from the various federal executive branch including presidential statements, and publications from federal agencies such as the U.S. Department of State.
