About Cases and Materials:

Professor Sievert has taught law and graduate school level national security law courses for over 12 years. He spent 25 years in the U.S. Department of Justice as a trial attorney, supervisor and designated international and national security coordinator. In this capacity he handled many major criminal and national security investigations and travelled to the Middle East, Balkans and Europe on sensitive assignments for DOJ. He has also published numerous articles in scholarly publications on important national security law topics. In this book he reviews and comments upon, and poses realistic questions related to, the most important national security cases and statutes of our time, combining his practical and directly

relevant operational experience with recent academic scholarship.

The book begins by reviewing the law often associated with threats posed by foreign enemies such as espionage, terrorism and treason. National security cases that arise in the domestic context, such as disclosure of intelligence information, export of sensitive technology and domestic terrorism, are then examined. A following section reviews sometimes controversial government actions utilized to gather information and detain individuals such as pen registers, National Security Letters, Foreign Intelligence Surveillance Act and

Title III interceptions, extradition and rendition as well as the screening of intelligence information through the Classified Information Procedures Act. In an important Chapter on the government's power to act in a crisis, Professor Sievert proceeds from the important civil war case of *Ex Parte Milligan* outlining martial law to a review of the last decade's critical cases on habeas corpus, military commissions and military assistance. In the final

section the casebook examines the War Power with historical cases on Executive versus Congressional authority, efforts to stop the Vietnam and Iraq wars and attacks on Yugoslavia and Libya, a Gulf War Chronology and summary of the effects of the War Powers Act and a review of the Authorizations for Use of Military Force 2001, 2002 as well as the government's recent legal justifications for drone attacks.

Anyone with a professional or personal interest in counterterrorism, espionage, or counterintelligence will find Sievert's Cases and Materials indispensable reading.

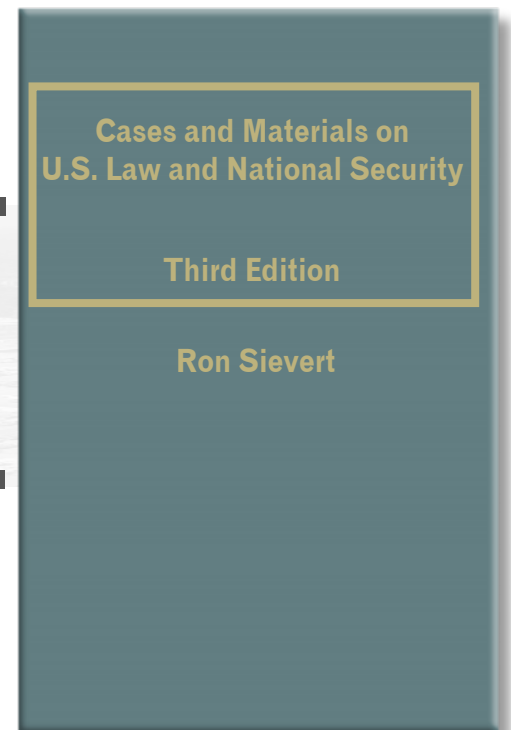
