## PREFACE



In academic law libraries there is usually a "ready reference" collection for quick searching in answer to law-related and peripheral questions. Although material may vary from library to library, there is a core collection, excluding primary material, that will be found in the majority of institutions.

Patrons knowledgeable in research techniques use these reference books easily. Others seek guidance from librarians or staff assistants in finding answers to "Who," "What," "Where," or "When" in volumes or databases that may be general or specific.

The first edition of this reference listing was based on an actual working reference collection at Southern Illinois University School of Law Library. Specific reference tools were identified in the card catalog and shelf list. Since that time an online catalog with additional search capabilities has replaced the traditional catalog. Reference shelves continue to be within easy reach of staff and patrons, as are terminals for utilization of electronic sources.

Later editions of this book went beyond the mere description of books on local shelves, including some reference tools that had not yet been acquired for this particular library. Search and description has extended beyond the immediate situation for this edition as well.

If at all possible, the latest edition of any given title has been listed. There is the inevitable change of title; several authors or editors have changed, as have a few publishers. Exponential growth in cyberspace continues, with an occasional volume available only online.

The basic collection described herein is still a print collection, with notation when there is varying format. Some CD-ROMs were actually received simultaneously with the book itself. Online databases of full text have continued to multiply among law publishers, as well as in private, corporate, and government sectors.

Description of several volumes devoted to location and utilization of online resources can be found in the Section entitled RESEARCH AND BIBLIOGRAPHY:SOURCES. In some reference tools, chapters or sections provide online searching data and in other works there is complete integration of description regardless of format, some with a word of caution regarding frequent changes in URLs.

New titles and editions have been integrated throughout this revised edition. Reference materials for individual states have not been listed. Each title in this book appears in a single category, although some could have been placed in several different subject areas. The Table of Contents suggests other categories under which a title might appear. The Index provides additional avenues of approach through author and title.

This book is intended to assist all persons who have need of identifying a reference tool: librarians, faculty, students, attorneys, paralegals, members of the university community and the lay public who seek answers in a law library.
